3.	Contact Tracing	
	Fiona Kinghorn updated the Board on the national strategic position for COVID 19 contact tracing. Sarah McGill outlined the Test, Trace, Protect system that has been established in Cardiff, which will go live on 1 st June. Initial testing will prioritise care home and hostel residents and staff, and key workers. A wider service is anticipated on 8 th June in line with the national system.	
	The establishment of the service is testament to the levels of partnership working currently taking place.	
	Real time local and regional data will be available. A Surveillance and Performance Working Group will be in place to review data that could be used to inform local lockdown decisions.	
	It was clarified that those testing negative but displaying COVID symptoms are advised to isolate.

	Sarah McGill outlined a proposal for temporary community safety and safeguarding governance arrangements in response to the crisis. The Community Safety & Safeguarding Partnership group will meet fortnightly until further notice to support COVID-19 recovery planning and delivery.
